

RULES FOR USE OF THE SWIMMING POOL

I - IT IS PROHIBITED

To enter the pool with open cuts or abrasions, skin changes or lesions likely to contaminate other users or whilst suffering from a contagious disease. The management may request a medical declaration indicating that the guest does not present a risk to others.

To enter the pool unduly suffering from the influence of alcohol or drugs or when feeling unwell

For unaccompanied children below the age of 12 years to enter the pool area

For non-swimmers to enter the pool unaccompanied

To bring animals into the pool or sun-bathing area

To take any form of glass-ware into the pool, including cameras, spectacles and sun-glasses (Swimming goggles and masks must have plastic lenses)

To enter the pool or surrounding area without an appropriate swimming costume

To enter the pool wearing ordinary shoes or sports trainers

To smoke, eat or drink in the pool, except if specifically authorized

To engage in inappropriate behavior likely to cause offence to decency and good standards

To spit, urinate or defecate in the pool

To dive in the pool or to push any other guest into the pool by force

To run in the immediate vicinity of the pool or to use fins, masks or other items that could be dangerous to fellow guests

To disturb other guests by excessive rowdiness or use of radios or similar music-players

II - IT IS COMPULSORY

To observe the displayed opening and closing times

To shower fully before entering the pool, including cleaning of feet using the appropriate foot disinfectant provided

To wear a swimming cap

To wait a suitable length of time (at least one hour) after eating a meal before entering the pool

To leave the pool as soon as possible in the case of thunderstorms or lightning

To use waste bins for all personal rubbish and to close umbrellas in windy conditions

III – DISCLAIMER

The Management of Il Selvino is not responsible for:

Any accidents or injuries that may happen to guests if due to their own negligent behavior

Any theft or loss of items left unattended in the pool or surrounding area

IV – SANCTIONS

Management and staff are responsible for carrying out this service and implementing regulations

If a guest fails to comply with the swimming pool regulations, they will be subject to admonition and, in cases of repeated non-compliance, may be refused access to the swimming pool area or expelled without any right of refund

If the conduct of guests is so grave as to jeopardize the regular use of the swimming pool, then the Management reserves the right call in the police or other public security agencies to enforce expulsion

V – DAMAGE AND OTHER ISSUES

All parts of the pool, equipment and constituent materials of the same should be used with care and attention. Any damage to such items or to surrounding hedges, fences, trees, lawns, flowers will need to be repaired or replaced at the guest's expense

Access to the pool and surrounding area may be restricted in the case of bad weather

POOL OPENING DATES AND TIMES

From 15th April to 15th October

From 08.00 to 20.00 daily (except when undergoing maintenance)

IMPORTANT

The swimming Pool is unattended and no life guard is present at any time

The floor of the pool can be slippery and is 1.4 meters deep (4.5 feet)

Diving is dangerous and strictly forbidden
